IN GOD WE TRUST Co-Chair Brenda Miles, Principal Alicia Harris-Bertram Elementary, Principal Abby O'Hair-Shady Grove Elementary, Principal Stewart-Burnet Middle School, Principal Jessica McMullen-RJ Richey Elementary. There is a national movement gaining strength throughout America to display the Nation Motto, In God We Trust, prominently in public and private buildings including school classrooms, council chambers, businesses, churches, and on law enforcement and private vehicles.

On June 16, 2021, Governor Greg Abbott signed into law a bill passed in the 87th Texas Legislature (SB 797, 87th (R) Texas). This law requires a public

elementary or secondary school to display in a conspicuous place in each school building a durable poster or framed copy of the United States national motto if posters or framed copies are donated to the school.

The Burnet County Republican Women have donated a framed copy of the National Motto, “In God We Trust” to each school in Burnet CISD and Marble Falls ISD. These donations are made possible through members generous donations.

Legislative Update

88th Legislative Session

Second Report – March 23, 2023

The final date for filing has passed with 6,177 bills in the House and 3,016 bills in the Senate for a total of 9,193 bills filed.

As anticipated, numerous bills have been filed relating to property taxes. I will update you next month on the momentum of those various bills. Today I am updating you on the additional bills filed by Senator Pete Flores and Representative Ellen Troxclair.

SB 1084 Relating to the eligibility of a district judge or former district judge for burial in the State Cemetery.

SB 1085 Relating to the authority of the Evergreen Underground Water Conservation District to impose certain fees.

SB 1233 Relating to companies in which employees have ownership interests through employee stock ownership plans.

SB 1234 Relating to an indicator of achievement for military readiness under the public school accountability system.

SB 1235 Relating to the temporary appointment of county jailers.

SB 1236 Relating to the use of certain weapons in or on the bed or bank of a navigable river or stream in certain counties.

SB 1237 Relating to compensation and leave for certain security officers or investigators commissioned as peace officers by the comptroller.

SB 1248 Relating to the prosecution of the offense of smuggling of persons.

SB 1426 Relating to municipal regulation of the removal of an Ashe juniper tree.

SB 1427 Relating to certain criminal conduct and organizations that threaten the security of this state and its residents and borders; increasing criminal penalties.

SR 273 Recognizing March 8, 2023, as Pleasanton Day.

SB 3 Relating to an increase in the amount of certain exemptions from ad valorem taxation by a school district applicable to residence homesteads, an adjustment in the amount of the limitation on school district ad valorem taxes imposed on the residence homesteads of the elderly or disabled to reflect increases in the exemption amounts, and the protection of school districts against the resulting loss in local revenue.

SB 5 Relating to an exemption from ad valorem taxation of a portion of the appraised value of tangible personal property that is held or used for the production of income and a franchise tax credit for the payment of certain related ad valorem taxes.

SB 10 Relating to benefits paid by the Teacher Retirement System of Texas.

SB 15 Relating to requiring public institutions of higher education students who compete in intercollegiate athletic competitions to compete based on biological sex.

SB 18 Relating to tenure and employment status at public institutions of higher education in this state.

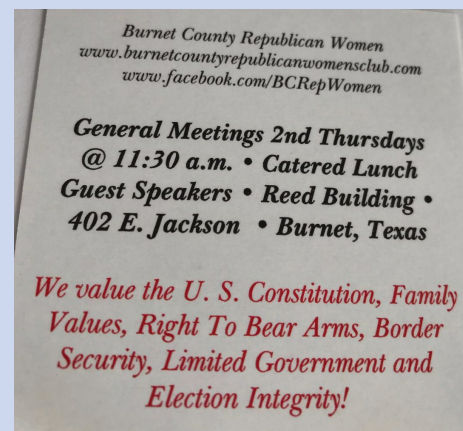

March Meeting Minutes

Burnet County Republican Women Minutes of General Meeting – March 9, 2023 Sylvester H. Reed Memorial Building – Burnet, Texas

Welcome, Call to Order, and Opening Ceremonies: President Mary Jane Avery welcomed everyone and called the meeting to order at 11:30 A.M., and a lunch was served. Commissioner Damon Beierle gave the invocation followed by the pledges to the American and Texas flags led by Precinct Chair Londa Chandler.

Introductions: Elected officials, precinct chairs, and guests introduced themselves. New members stood and were recognized.

Approval of Minutes: The February minutes were published in the newsletter. There were no corrections or additions. The minutes stand approved as distributed.

Membership: Janice Estill reported that we have three new members today for a total membership of 107. Mary Jane congratulated members for making a luncheon reservation. She reminded everyone to reserve either through EventBrite or by contacting Carolyn Alexander. Also, contact Janice if you are not receiving emails.

Caring For America: Our donations this month go to the Fisher House. Deborah Smith explained that this is a “home away from home” for veterans. There are eight locations in Texas and 91 across the US and the UK. Donations will go toward gas and other needs. Checks should be made to the Fisher House. At the end of the meeting, Deborah reported that \$1099 was collected.

Campaign Activities: Mary Jane again recognized Linda Berggren for being one of the top callers in the state for registering new voters. Volunteers are needed to work the booth on Friday and Saturday at the Bluebonnet Festival. A sign-up sheet was placed on each table.

Program: Gail Teegarden introduced our speaker, Dr. Dana Myers, Republican Party of Texas Vice Chair. Her topic was ERIC, Electronic Registration Information Center. ERIC’s role is supposed to be to improve accuracy in voter registration. Texas joined ERIC in 2020 at a cost of \$1.5 million plus annual dues. Twenty-seven states are members. It does not appear that we are getting our money’s worth from this company. Member states are not allowed to talk to each other. She posed the questions: why are we still in ERIC and what are we really getting for our money? Two bills have been filed in Texas to get out of ERIC. We want to make sure our elections are free, fair, and transparent for every citizen. Mary Jane presented Dr. Myers with a book titled Green Card Warrior by Nick Adams which will be placed in a local library in Burnet County.

Announcements:

- Stacy Smith gave a report from Ellen Troxclair. All bills must be presented by the end of this week. Two of the bills submitted by Ellen deal with a ban on tax payer dollars for lobbyists and one about transgender.
- Mary Jane gave an announcement from County Chair Kara Chasteen. Their next meeting will be the second Thursday of April at 6:30 P.M. at the Reed Building.
- Wine Wednesday – March 29th at Adriano’s.
- Janice Estill gave a report from the Burnet County Republican Club. She recognized Londa Chandler for her service as past President of the club and presented her with a card and a red bud tree. The next meeting will be May 15th at the Ragtime Oriole with guest speaker Calvin Boyd.

Your copy should address 3 key questions: Who am I writing for? (Audience) Why should they care? (Benefit) What do I want them to do here? (Call-to-Action)

Create a great offer by adding words like "free" "personalized" "complimentary" or "customized." A sense of urgency often helps readers take an action, so think about inserting phrases like "for a limited time only" or "only 7 remaining!"
