Dr. Dana Myers is a Medical Business Consultant for the health law firm Spiers Group. Dr. Myers works with a Texas-based investment and development group working to build a critical need medicine and saline bag manufacturing plant in Texas, rather than depending on China or other foreign countries. Myers received her medical degree from Boston University School of Medicine and completed her general surgery residency at the Michael E. DeBakey Department of Surgery, Baylor College of Medicine in Houston. Dr. Myers was an Associate Clinical Professor of Surgery and taught many surgery residents, medical students, and visiting medical and military medical personnel in the Texas Medical Center.

Dr. Myers is a two-term Vice-Chair of the Harris County Republican Party, former VP Membership for the Texas Federation of Republican Women Executive Board (TFRW), past Regional Director for the Republican Party of Texas/TFRW Strike Force for Harris and the surrounding counties, past

HCRP Co-Chair of Engagement, past RPT Communications Task Force member, and two-term President of Magic Circle Republican Women's Club in Houston. Dr. Myers is married to Dr. Jon Spiers, a former Republican General Land Office Candidate, and is a longtime resident of Houston, Texas.

Dr. Dana Myers was elected by the delegates at the Texas State Republican Convention in June 2022 to be the new Vice Chairman of the Republican Party of Texas.

Through her proven leadership, Dr. Myers reorganized, streamlined, and increased transparency in the Harris County Republican party infrastructure during her first tenure as Vice-Chair while supporting and recruiting additional grassroots volunteers. During this time, Dr. Myers also served as the Regional Director of the Republican Party of Texas (RPT)/Texas Federation of Republican Women (TFRW) Voter Engagement Project effort to recruit volunteers from Harris and the seven surrounding counties to register new Republican voters. As part of this statewide effort, many of these volunteers later deployed to battleground districts in Texas during the midterm and general Presidential elections to help with GOTV efforts. This statewide project was responsible for almost 213,000 of the total 318,000 new Republican voter registrations, which managed to be the statistical vote difference to win four critical Texas Republican house seats.

During her second and current term as Vice-Chair of the Harris County Republican Party under Chairman Siegel, Dr. Myers once again helped to build and rebrand the party to increase its community engagement, communication, and voter registration efforts. With her special interest in training, recruitment, and increasing Republican voter turnout, Dr. Myers led an additional effort to recruit, train, and mobilize county and precinct chairs, and volunteers, across Texas using the latest technology.

The new Vice Chair's goal is to continue to strengthen the party, build the party infrastructure to amplify grassroot voices and goals, support the Chairman, party leadership, and the Republican party legislative priorities and platform.

I'm excited to share I've been elected by my fellow Texas House Republican Caucus members to serve on the <u>Policy Committee!</u> We'll be meeting early each day to review every single bill on the House <u>calendar</u>, and provide voting recommendations for the entire Caucus. It's an honor to be entrusted with this role, and it is another way I'll be working to pass our conservative priorities this session.

I appreciate our visitors, and the more detailed conversations we've engaged in as Session progresses. Shout-out to <u>Boerne ISD</u>, <u>Texas Pain Society</u>, <u>Bluebonnet Trails Community Services</u>, <u>Leander ISD</u>, <u>American Society of Landscape Architects</u>, <u>Special Olympics</u>, <u>Texas Education 911</u>, and <u>Marble Falls Economic Development Foundation</u>, among many other individuals and groups, for making the journey to your office here at E1.208 in the <u>Capitol</u>.

When the House is in <u>Session</u> you may see me walking with fellow Representatives, depending relationships, new and old, for the benefit of our District. Bills are now being referred to committees, including to our <u>Homeland Security and Public Safety Committee</u> and <u>Culture</u>, <u>Recreation</u>, <u>and Tourism Committee</u>, and the work of evaluating and improving those proposals is just part of what has been keeping me constantly engaged. It is worthy work. As always, please keep me in your prayers.

88th Legislative Session First Report – February 19, 2023

Key Legislative Deadlines

Bill pre-filing: November 12, 2022 1St day of session: January 10, 2023

60-day bill filing deadline: March 10, 2023

Governor Abbott's Emergency Items

Governor Abbott delivered his biennial State of the State address on Thursday, outlining his priorities for the legislative session. His designation of seven emergency items allows those matters to be taken up immediately by the Legislature. Other legislation will need to wait for March 10th or day 60, as prescribed by the Texas Constitution. House and Senate committees can immediately post for public hearings on the seven emergency items, titled:

Fight the fentanyl crisis.
Secure the border.
End revolving-door bail.
School safety.

Education freedom. End Covid restrictions forever. Cut property taxes.

Lt. Gov. Dan Patrick Announces Top Priorities

Lt. Gov. Patrick released his 30 priority bills for the 2023 session in a press release

(https://www.ltgov.texas.gov/2023/02/13/lt-gov-dan-patrick-announces-top-30-priorities-for-the-2023-legislative-session/) on Monday.

Patrick's list reserves the low-numbered Senate Bills 1-30 for his priorities and will be the mechanism for legislative action on proposals. **Counties stand to directly benefit** from several of the bills on Patrick's list, including the state budget, new financial assistance from the state for rural law enforcement funding, additional state mental health beds, preparations for Texas' future water needs and potentially others. Only the budget (Senate Bill 1) has been filed so we do not yet know authors or details beyond brief descriptions in Patrick's press release.

Bills Authored / Joint Authored / Coauthored by Senator Pete Flores

SB 748 (Flores) Relating to the provision of state aid to certain local governments to offset the cost of the exemption from ad valorem taxation of the residence homestead of a 100 percent or total disabled veteran.

SB 749 (Flores) Relating to the administration of a medication and the ordering and administration of an immunization or vaccination by a pharmacist.

SB 750 (Flores) Relating to eligibility for service on the board of directors of an appraisal district.

SB 751 (Flores) Relating to elimination of limitations periods for suits for personal injury arising from certain offenses against a child.

SB 752 (Flores) Relating to the delivery and direct shipment of certain alcoholic beverages to ultimate consumers; creating criminal offenses.

SB 753 (Flores) Relating to the powers and duties of the office of the attorney general with respect to certain laws governing the installation and use of tracking equipment and access to certain communications.

SB 754 (Flores) Relating to increasing the criminal penalty for causing bodily injury while resisting arrest, search, or transportation.

SB 755 (Flores) Relating to the reimbursement of state employees for groceries consumed while traveling on official state business.

SB 756 (Flores) Relating to the reporting of electronic political contributions accepted by certain political committees.

SB 830 (Flores) Relating to the authority of a taxing unit other than a school district to establish a limitation on the amount of ad valorem taxes that the taxing unit may impose on the residence homesteads of individuals who are disabled or elderly and their surviving spouses.

SB 831 (Flores) Relating to in-service training on identifying abuse, neglect, and illegal, unprofessional, and unethical conduct in certain health care facilities.

SB 832 (Flores) Relating to appeals to justice courts of certain appraisal review board orders.

SB 876 (Flores) Relating to the licensing and regulation of dog and cat breeders; expanding the applicability of an occupational license.

SB 1005 (Flores) Relating to the adoption of physical fitness programs and standards for law enforcement officers employed by the office of the attorney general.

SB 1006 (Flores) Relating to the minimum instruction requirement for the boater education program and the disposition and use of money received by the Parks and Wildlife Department from the boater education program.

SB 1007 (Flores) Relating to defenses to prosecution for certain criminal offenses involving material or conduct that may be obscene or is otherwise harmful to children.

SB 1008 (Flores) Relating to establishing residency for purposes of admission into public schools.

SJR 42 (Flores) Proposing a constitutional amendment to authorize a political subdivision other than a school district to establish a limitation on the amount of ad valorem taxes that the political subdivision may impose on the residence homesteads of persons who are disabled or elderly and their surviving spouses.

SR 146 (Flores) Recognizing February 22, 2023, as Sheriff's Association of Texas Day at the State Capitol.

SR 147 (Flores) Congratulating Bobby Ott of Temple ISD on being named the 2022 Superintendent of the Year.

SR 188 (Flores) Recognizing Gillespie County Sheriff Buddy Mills on the occasion of Sheriff's Association of Texas Day at the State Capitol.

SB 589 (Johnson / Flores) Relating to a health literacy plan developed by the statewide health coordinating council and the inclusion of health literacy in the state health plan.

SR 148 (West / Alvarado / Bettencourt / Birdwell / Blanco / et al.) Recognizing Opal Lee on the occasion of the unveiling of her portrait in the Senate Chamber.

SR 174 (Creighton / Alvarado / Bettencourt / Birdwell / Blanco / et al.) Recognizing February 15, 2023 as Orange and Maroon Legislative Day.

SB 287 (Huffman, Author – Campbell / Eckhardt / Flores / Hinojosa / Zaffirini) Relating to the prosecution of the offense of terroristic threat.

SB 330 (Hall, Alvarado, Bettencourt, Blanco, Eckhardt, et al., Authors – Creighton / Flores / LaManitia / Middleton / Sparks) Relating to the resilience of the electric grid and certain municipalities; authorizing an administrative penalty.

SB 474 (Springer, Author – Flores) Relating to the minimum motor vehicle liability insurance coverage requirement for damage to or destruction of property of others.

SB 554 (Hughes, Author – Blanco / Flores) Relating to an appraisal procedure for disputed losses under personal automobile insurance policies.

SB 728 (Huffman, Author – Flores / Zaffirini) Relating to the reporting of mental health and intellectual disability information with respect to certain children for purposes of a federal firearm background check.

SCR 4 (Eckhardt, Author – Flores / Hinojosa / West / Whitmire / Zaffirini) Directing the Texas Facilities Commission to name the Capitol Complex Child Development Center "Emma's Garden" in honor of Emma Barrientos.


