Burnet County Republican Women PAC Minutes of General Meeting – March 11, 2021 Sylvester H. Reed Memorial Building – Burnet, Texas

- Thank you to BCRW Vice President Carolyn Alexander, her Hospitality Committee, and Kevin for our delicious lunch.

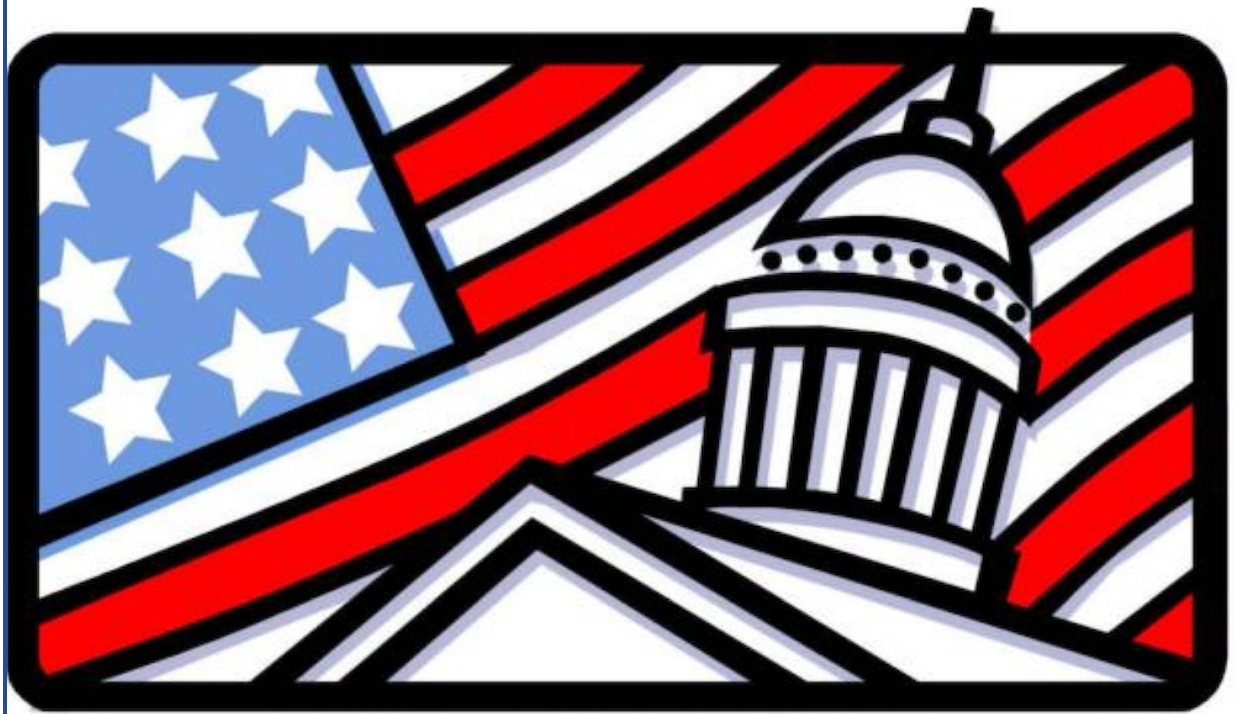
Door Prize: Carolyn Richmond won the door prize donated by Texas Elite Meats.

ALL HANDS ON DECK TOMORROW!

Below is information on how you can take action **THIS WEEK** on the Election Integrity bills in the Texas State House:

3. Please **FORWARD** this email to your contacts who live in Texas so they can also take action with us.

Texas Republicans' top-tier election integrity bills are scheduled for public hearings in legislative committees this week, giving citizens their first chance to formally weigh in on the high-priority measures.

Thursday morning, the House Elections Committee will hear public testimony on [House Bill 6](#). The comprehensive election reform bill—dubbed the “Election Integrity Protection Act of 2021”—was authored by the committee’s chairman, State Rep. [Briscoe Cain](#) (R–Deer Park), and now has [39 co-authors](#).

(Use As Talking Points)

HB 6 includes provisions that would:

- Protect voters from intimidation by people pushing unsolicited assistance, a practice known as “voter ambush” (mirroring protections

- in [HB 611](#));
- Clarify the right of poll watchers to be “near enough to see and hear” election officials’ activities (language also found in [HB 1724](#));
- Prohibit public officials from distributing unsolicited mail-ballot applications (also included in [HB 25](#));
- Specify who can be inside a polling place or ballot-processing location (similar to [HB 1128](#));
- Require expedited court action in election fraud cases;
- Strengthen penalties for several election-related offenses, including making election fraud offenses a second-degree felony (also a provision of [HB 574](#)).

Texans who want to testify on HB 6 in person can [sign up at the Capitol on Thursday](#). Those who don’t wish to speak at the hearing can [submit written testimony online](#).

Last week, the committee [heard public testimony on nearly a dozen measures](#).

H.B. 6 - Election Integrity

The House Elections Committee will hold a hearing on THURSDAY, APRIL 1st, beginning at 8:00 a.m. on H.B. 6, the House "omnibus" Election Integrity bill.

[HB 6 Text](#) (Similar to SB 7) is provided for your review and consideration. I also am including the [Notice of Hearing for April 1st](#) which provides links for those who wish to go to Austin to testify, and for those who want to submit their comments in writing. Written comments through the House portal **MUST** be submitted **BEFORE** the conclusion of the hearing.

You also may call the Committee Clerk and each member of the committee to provide your comments.

Property Tax Reform - Basics



Property Tax Reform - Basics

Property Tax System Basics

Property taxes are local taxes, assessed locally, collected locally and used locally and provide the largest source of money local governments use to pay for schools, streets, roads, police, fire protection and many other services. Texas law establishes the process followed by local officials in determining the value for property, ensuring that values are equal and uniform, setting tax rates and collecting taxes.

Texas has no state property tax. The Texas Constitution and statutory law authorizes local governments to collect the tax. The state does not set tax rates, collect taxes or settle disputes between you and your local governments.

The **property owner**, whether residential or business, is responsible for paying taxes and has a reasonable expectation that the taxing process will be fairly administered. The property owner is also referred to as the **taxpayer**.

An **appraisal district** in each county, administered by a chief appraiser, appraises the value of your property each year. The appraisal district's board of directors hires the chief appraiser. Local taxing units elect the board directors and fund the appraisal district based on the amount of taxes levied in each taxing unit. For more information about your local appraisal process, please contact your county's appraisal district. The appraisal district can answer questions about exemptions and how your appraised value was determined.

Local **taxing units**, including the school districts, counties, cities, junior colleges and special districts, decide how much money they must spend to provide public services. Property tax rates are set according to taxing unit budgets. Some taxing units have access to other revenue sources, such as a local sales tax. School districts must rely on the local property tax, in addition to state and federal funds.

Unfunded Mandates

It's no secret that Texas has relied on property taxpayers to pay for more and more over the years, but it's not just the responsibility for funding schools that has been pushed down to local property owners. The Legislature regularly requires that counties enact expensive new policies and programs, known as unfunded mandates, expecting local property taxpayers to pick up the tab.

Texas counties and local property taxpayers face billions of dollars-worth of unfunded mandates from both the state and federal governments.

Unfunded mandates drive up property tax bills by increasing the size and cost of county government.

Unfunded mandates **remove accountability from state government spending.**

Lower revenue caps are a one-size-fits-all approach based on the faulty assumption that the need for services is steady from year to year. Local revenue needs often spike above or below proposed revenue limits.

Revenue caps won't cut property taxes. School taxes comprise more than 54 percent of an average homeowner's property tax bill. County taxes account for only 16 percent of an average homeowner's property tax bill.

Revenue caps limit the ability of local governments to provide essential

services and limit local governments' disaster and emergency response.

Local governments have no protection against state mandates. Revenue caps let the state dictate local budget decisions.

Local economic development incentives will disappear.

Cost drivers and inflation tough on local government budgets. Fuel and road maintenance materials costs rose significantly in the last decade. Employer health care costs continue to rise rapidly.

Bond ratings drop as reserve funds are depleted. Local governments need flexibility to fund essential services. Taking away budget control will force bond offerings and borrowing to cover costs. Revenue caps lead to greater local government debt.

One size **does not** fit all! Because many county services are mandated by the state, they cannot be cut from the budget. Critical discretionary services could be threatened.

There are at least 48 bills that have been filed this session regarding property taxes. Our very own Rep. Terry Wilson has filed HJR 43 proposing a constitutional amendment to provide that a residence homestead is not subject to seizure or sale for delinquent ad valorem taxes. I strongly encourage you to educate yourself on these bills and make your opinion known.

To make it stronger, use upper and lower case letters, numbers, and symbols like ! " ? \$ % ^ &) .*

12. After you have entered a strong password, click the **"Reset Password"** button.

You will receive a second email from WordPress with "[TFRW] Notice of Password Change" in the subject line to confirm that your password was successfully changed.

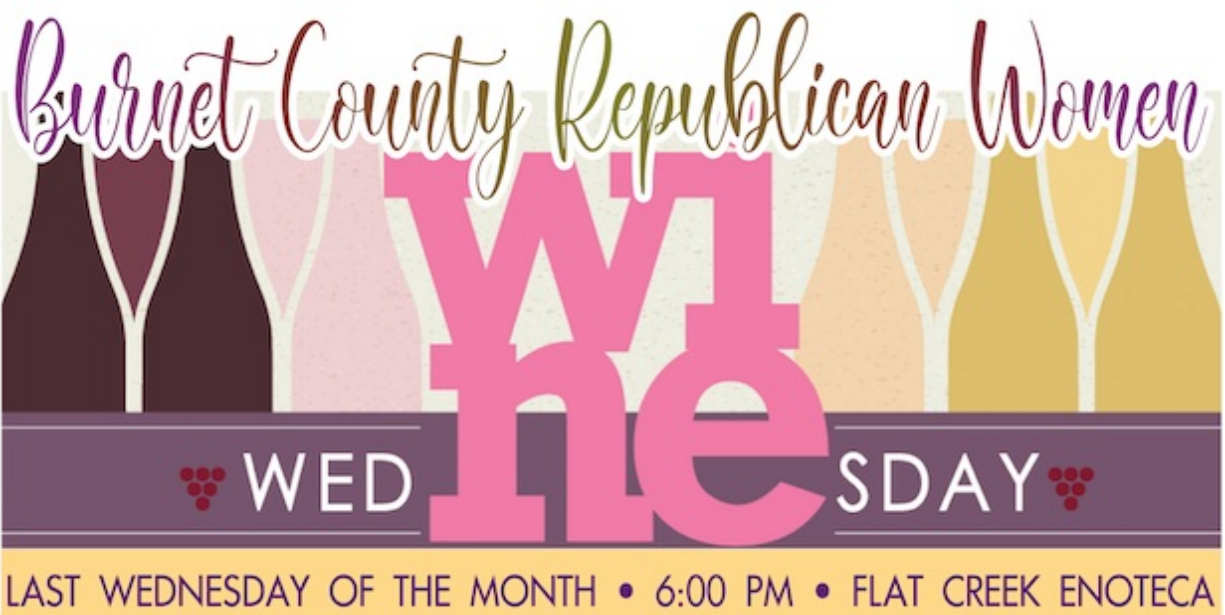
