## **Minutes from January Meeting**

### **Burnet County Republican Women PAC Minutes of General Meeting – January 9, 2020 Sylvester H. Reed Memorial Building – Burnet, Texas**

Call to Order and Opening Ceremonies: President Stripling greeted everyone to the first meeting of the BCRW for 2020 at 11:35. As it was Law Enforcement Appreciation Day, she recognized the officers in attendance and those wearing blue. Following was the invitation to lunch. While in the lunch line, folks were asked to sign up to volunteer for the Chili Cook-Off and making cookies for the Candidate Forum. The general meeting was called to order at 12:02. Precinct Chair 10 John White gave the Invocation and County Clerk Janet Parker led the pledges to the American and Texas flags.

Recognition of Officials, Guests, and New Members: Elected and appointed officials, precinct chairs, and TFRW officers were introduced and recognized. Guests and new members were welcomed.

Program: Judge James Oakley introduced speaker Texas Railroad Commissioner Christi Craddick. The Railroad Commission is the most important Texas agency. It is responsible for the regulation of the huge oil and gas industry. President Trump's deregulation policies have made it possible for the Railroad Commission to change to "smart" regulation. They have been able to update the IT system which has sped up the permitting process. The agency pays a severance tax to the state's "Rainy Day" fund. This year it contributed \$11.5 billion. \$1 billion went to public schools; \$2 billion went to water issues; \$6.5 went to road structures. Texas also mines coal and other minerals. Christi emphasized the commission is prepared for the anticipated growth of the oil and gas industry in Texas. In closing, she stressed how important it was to vote and for everyone to work hard getting out the vote. President Trump must be re-elected to ensure his "America first" policies of deregulation and strategies continue.

Approval of Minutes: Treasurer Carolyn Richmond had a correction to December's Treasurer's report. Corrected balance is \$10,004.35. Minutes were approved as amended.

Treasurer's Report: Treasurer Carolyn Richmond reported \$10,133.54 in the treasury as of January 1, 2020 and \$617.09 in the scholarship fund.

#### **Committee Reports:**

- Membership – Dottie Stueckroth reported there were 2 new members, 2 renewals and 1 new associate for a total of 63 members and 13 associates.
- Campaign Activities – Mary Jane Avery reported so far there are 12 elected officials and candidates who will have booths at the Chili Cook-Off. Karyn Mason is handling decorations and can use help setting up. Volunteers should come at 8:00 am to help.

Mary Jane also reminded members of the phone calling efforts being made to promote voter registration. There is now the Red Dialer system which eliminates wrong numbers and no

answers – saves time and frustration.

- Other Fundraising - Darlene Hargett reported on the silent auction at the Chili Cook-Off. Some items have been donated. She is looking forward to more.
- Legislative – No report
- By-Laws – No report
- Caring for America – In Jessica McMurry's absence, President Stripling reported, in keeping with the TFRW, January's project was donations to Fisher House - a foundation which helps provide military families with their needs while hospitalized.

**Other Reports:**

- Burnet County Republican Chair – President Stripling thanked all those who contributed food and drinks for the Mix, Mingle, and Draw event held at the Burnet County Court House on December 19, 2019. Candidates drew for positions on the ballot at the event.
- Burnet County Republican Club – Londa Chandler discussed the procedure for obtaining a mail-in ballot. She suggested helping elderly neighbors obtain one, helping them fill it in, and even mailing it for them.
